THE GAMA CONSTITUTION

PREAMBLE

The problems of group life are central to survival in our time, containing as it does, implications for the surivval of the species itself in an era torn by the specter of atomic warefare, revolution, genocide, starvation, and overpopulation. Knowledge and mastery of group life are crucial imperatives now.

Yet, the knowledge of the proper balance between involvement in group life and individuality in a viable community was lost in the west with the fall of the classical tradition in the west.

Instead of finding a proper balance between these two needs for individuality and community, western man has oscilated between two extreems; either crushing man into the total community at the cost of destroying individuality, or isolating him from the community in a private prison of individualism.

One of the objects of this learning community is then, the rediscovery of the behavioral realities of the Aristotelian view of membership in a shared ethical community that makes man at once more individual and more communal that he has been since the golden age of the Greek city-state. Membership in an ethical community speaks to an accepted committment and the development of members who feel a responsibility for the community that extends beyond personal interestly taste, and idiosyncracies.

To accomplish this objective there must be a public agreement with which they identify and which they are concerned to support; even to the point of drinking a Socratic cup of hemlock; that public thing in the probram in the constitution, and it it to the rediscovery of this knowledge and mastery of balanced group life that the constitution of this learning community is directed.
