Construction of the Seminar II Building will add the necessary classrooms, labs and faculty and staff offices required to support the student enrollment forecast for the next ten years. The design (estimated approval in March 2000) and construction (estimated to begin in August 2001, contingent on Board approval and legislative funding) will be consistent with the Campus Master Plan. This building will become the primary classroom building at the College.
