## Approval of Architecture & Engineering Contract for the First-Year Housing Project

Vice President for Finance and Administration John Hurley recommended that the Board award a contract for architecture and engineering work on the First-Year Housing Project to Mahlum Architects. He said that the college has retained bond counsel and that staff will return at a future meeting with a recommendation for a project budget.

Motion 2017-05

Mr. Kessler made a motion to award an architecture and engineering (A/E) contract for the design of the First-Year Housing Project to Mahlum Architects of Seattle, WA for an amount not to exceed \$3,100,000.

He discussed the progress of group examining entrepreneurship at Evergreen and the status of the Strategic Messaging and Promotion project.
