In accordance with Governor Inslee's Proclamation 20-28, and to curtail the spread of COVID-19 this meeting took place via Zoom. All participated remotely.

Chair Karen Fraser called the meeting to order at 2:01 p.m. and Secretary Miguel Pérez-Gibson confirmed a quorum.

## Chair's opening remarks

Chair Karen Fraser commented that she and Trustee Miguel Perez-Gibson attended the wonderful inaugural raising of the flag of the Squaxin Island Tribe. It was an impressive, memorable and inspiring occasion. The flag raising reflects a permanent physical land recognition, and a friendship and close cooperating relationship between the college and the Squaxin Island Tribe. It symbolizes our intention to continue to strengthen our relationship over the next 50 years. The college is leading the way once again on Tribal and Indigenous programs and relationships.

The Executive Committee recently met and discussed the need to plan for the board retreat scheduled in September. Chair Fraser appointed a Board Retreat planning committee consisting of Trustee Ed Zuckerman (Committee Chair), Chair Fraser, and Secretary Goldberg. She asked that Trustees please provide input on the upcoming retreat agenda. Chair Fraser also shared that it is good practice for Boards to complete self-evaluations. She noted that Executive Associate to the President and Secretary to the Board of Trustees Susan Harris and President Elect John Carmichael will conduct research on Board evaluations and provide that information to the Board.
